I or my legal guardian is aware that participation in the event may endanger my physical integrity - also with regard to infection with the COVID-19 virus. I have weighed this risk and accept this expressly with my participation in the event. Furthermore, I waive to this extent any claims for compensation against the operator of the sports facility or organizer in the event of such an infection, provided that they or the persons attributable to them do not act intentionally or grossly negligent.

I, as a participant, expressly acknowledge that the event will take place in compliance with the provisions of the laws, regulations, directives and decrees issued to deal with the Corona crisis and confirm that I am aware of all these legal provisions. Furthermore, by participating in the event during the entire period of the event, I undertake to comply with the legal provisions and/or the house rules and the general regulations of the federal sports federation responsible for the event being held, as well as all directives, guidelines and recommendations issued by the federal sports federation responsible in connection with the Corona crisis,

I acknowledge that the operator of the sports facility or organizer is entitled to monitor compliance with the above regulations. This concerns the keeping of booking or access and stay systems and records. These data will be used for "contact tracing" within the time frame of the necessary follow-up of possible illnesses. Furthermore, I undertake to comply immediately with any instructions given by the operator of the sports facility or organizer or their authorized third parties to comply with the above regulations. Failure to do so may result in a reprimand from the sports facility or exclusion from the event. I must also comply with any reprimand or exclusion without delay.

I certify that I am not knowingly infected with the COVID-19 virus or have been in contact in any manner with any person infected in this regard or have not been in a COVID-19 risk area within the 14 days prior to entering the athletic facility.

Furthermore, I confirm that I have not been or am not currently in (even domestic) quarantine due to such a stay or due to contact with an infected person, and that I do not belong to one of the risk groups according to the regulations related to the management of the Corona crisis.

In case of non-compliance with the COVID-19 regulations or a violation of the contents of this declaration of consent by me, I am liable to the operator of the sports facility or the organizer. I expressly agree to indemnify and hold them harmless without exception in the event of a claim by a third party based on a violation of this declaration of consent by my entry, stay and/or behavior at the sports facility as well as at the entire event for any reason whatsoever.

I am aware that I can revoke this declaration of consent at any time. However, the revocation of the declaration of consent simultaneously leads to a deregistration of the registered event.

Furthermore, I am aware that this consent form is only valid for the duration of this event, where I have agreed to it by ticking and signing.
